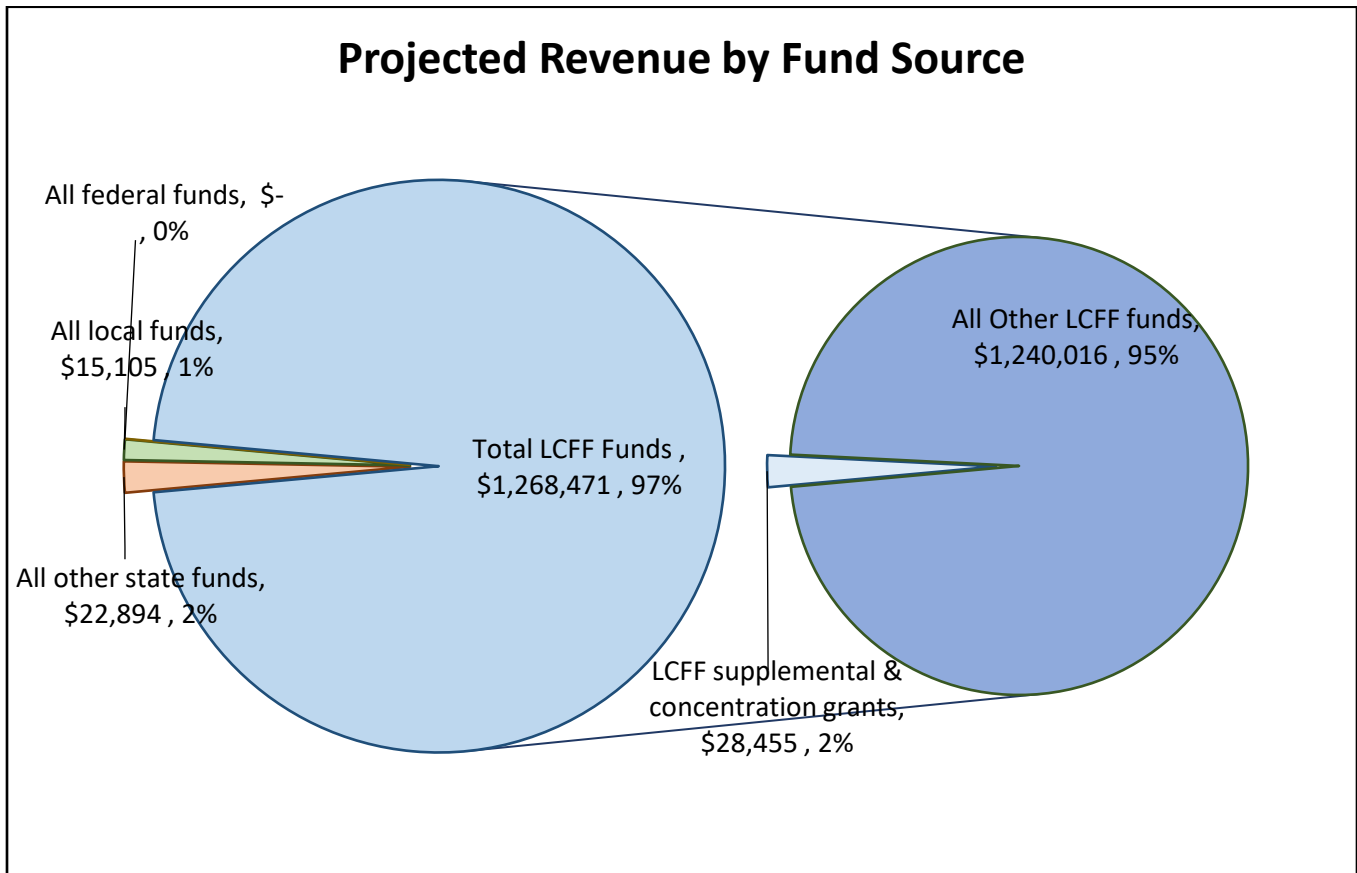

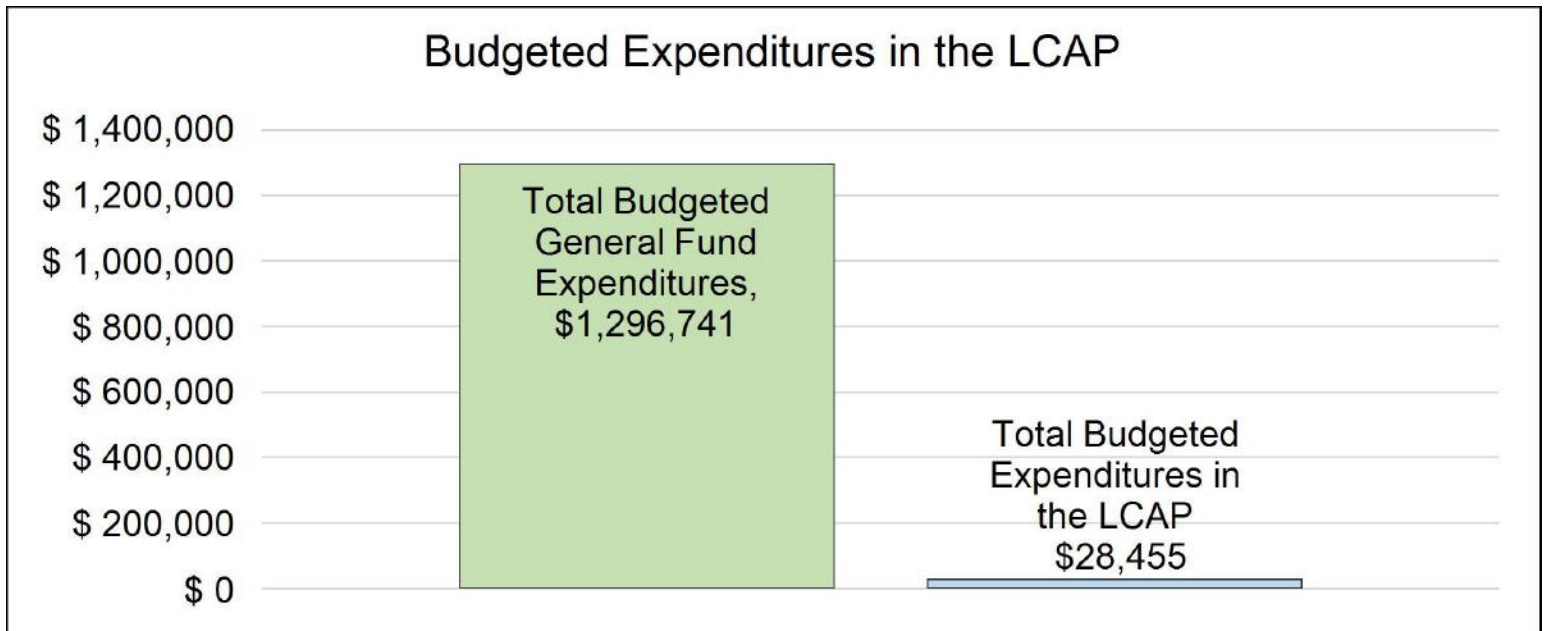


This chart shows the total general purpose revenue Santa Rosa Accelerated Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Santa Rosa Accelerated Charter School is \$1,306,470, of which \$1,268,471 is Local Control Funding Formula (LCFF), \$22,894 is other state funds, \$15,105 is local funds, and \$0 is federal funds. Of the \$1,268,471 in LCFF Funds, \$28,455 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

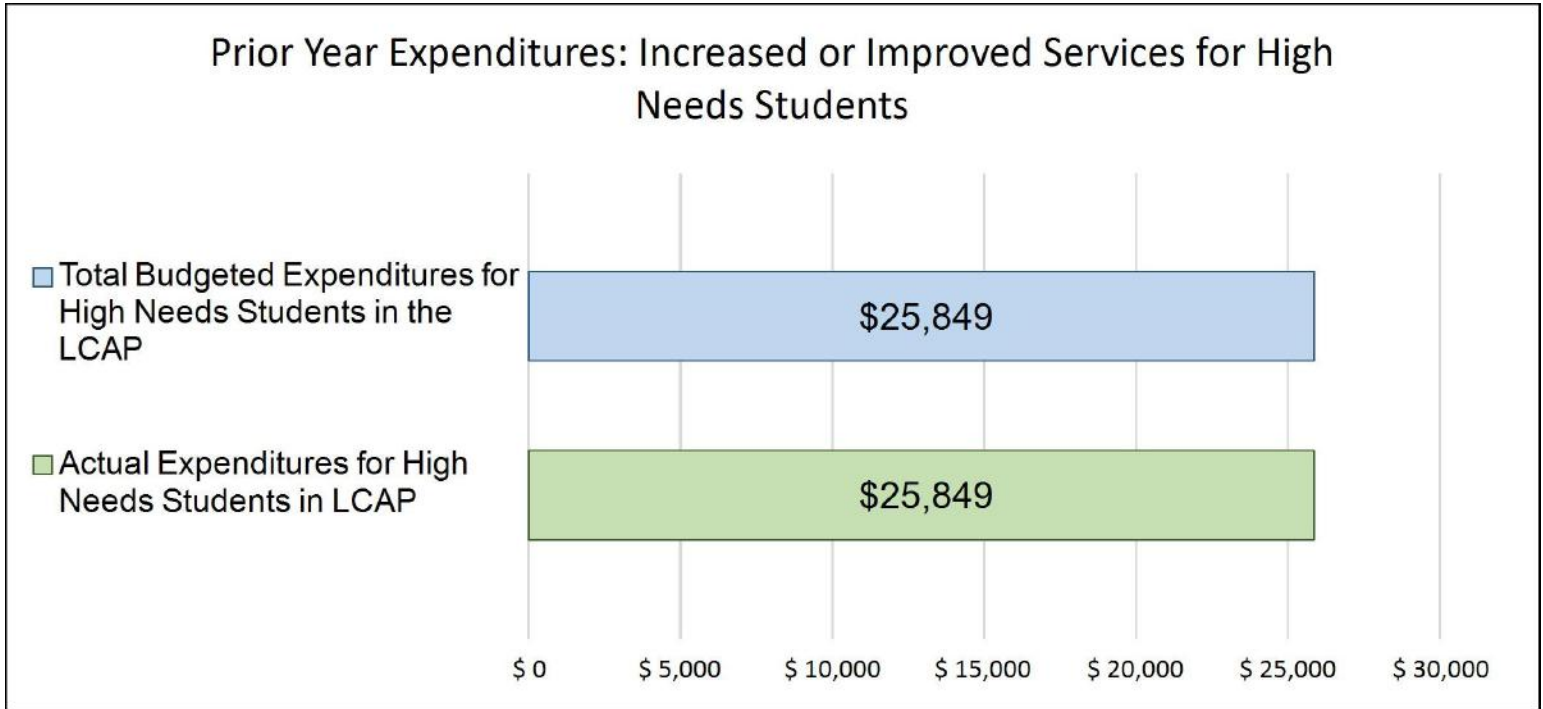

Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

The Santa Rosa Accelerated Charter School serves students who show the interest, ability, and promise of succeeding in an academically challenging and specialized setting. Students are provided high-interest, standards-based, real-world experiences for learning at the level in which growth proceeds most effectively. Integration of technology and making connections across disciplines are key elements of the educational experience. These experiences provide students with opportunities to become intrinsically motivated, competent, and life-long learners.

SRACS students are admitted through the Charter School Lottery Process. SRACS students come from a wide variety of schools and districts around Sonoma County. Of the current 128 students, 28 are designated GATE- 8 in 5th grade and 20 in 6th. 6 students have IEPs and 3 have 504 plans. SRACS has no English Language Learners this school year. Since SRACS is an intermediate program, most of the English Learners have been reclassified by 5th grade. SRACS is quite diverse with over 12 languages spoken in the home and over 20 ethnicities represented in the student body.

SRACS is located in Northern California where the community has been greatly impacted by fires and the pandemic. The social and emotional well-being of the whole community (students, families, and staff) is a primary focus. SRACS is supported by an involved and active parent group (SFPO). Community involvement is an important part of the program. Students engage in frequent excursions and host guest speakers from the community to engage in real-world experiences.

The SRACS Curriculum revolves around investigating the standards with Depth and Complexity. This approach is based on the work by Sandra Kaplan, USC. Students work together to apply their conceptual understanding of the standards in various and meaningful ways. The lens through which students make meaning of curriculum is an area of focus that is determined by student needs and interests. At SRACS, each child is provided a rigorous challenging curriculum in a safe and affirming environment allowing children to form complex understandings of the subjects and giving them a system to understand new content with depth and complexity. These increased options

provide students with enriched educational opportunities far beyond the traditional elementary school setting while simultaneously providing the unique prospect of becoming stewards of their own learning. Program development is based on collaboration, metacognition, and connectivity. Students are provided many opportunities for self-reflection and assessment through the curriculum that values the learning process equally to that of the finished products. As a result, students develop the critical thinking and metacognitive skills necessary to guide their own learning. Whenever feasible, the curriculum is interdisciplinary and provides students with real-world applications of their learning.

Reflections: Successes

The Santa Rosa Accelerated Charter school was awarded the status of a National Blue Ribbon School in 2016. SRACS consistently achieves above grade level in all academic areas, has low suspension rates, and has excellent attendance.

In the 2022 Dashboard SRACS was in the green for both English Language Arts and Mathematics. Students scored 56.6 points above standard in ELA and 54.2 points above standard in Mathematics.

Our 2021-2022 CAASPP test scores showed that 77.6% of our students met or exceeded standards for ELA and 79.36% of our students met or exceeded standards for Mathematics.

Reflections: Identified Need

In response to the traumas of the past few years, there is a growing need for more social-emotional support and services. Professional development will be an important component of the successful implementation of the SEL program.

LCAP Highlights

The SRACS LCAP goals revolve around ensuring a high-quality educational experience for all students. In order to achieve the academic component of this goal, teachers must have ongoing professional development and time to collaborate and plan together. Students will engage in tiered learning activities incorporating Depth and Complexity including excursions into the community and hosting guest speakers. Technology will support individualized learning.

The school culture and climate will be supported at the individual, family, and school-wide levels. Individual student needs will be assessed and addressed through the Student Study Team (SST) process, instructional differentiation for learning styles or special needs, and staffing for an instructional aide and counseling services. The social-emotional curriculum will support student mental health. Regular communication is a key component of family and community engagement.

The facilities of the SRACS campus will be supported by the hiring of Highly Qualified staff who are encouraged to develop as pedagogical leaders. The physical environment of the school will be clean and safe, and provide a flexible environment conducive to teaching and learning.

A summary of the feedback provided by specific educational partners.

There was a great deal of feedback and conversation about the changing needs of the school and community since the last LCAP. Teachers and staff feedback centered around continuing the Gifted and Talented Education methodologies- specifically the multi tiered levels of instruction. Teachers emphasised the importance of ongoing high quality professional development especially the CAG conference.

Many of the technology goals have been achieved and required revising. Communication between all stakeholders was identified as an ongoing need.

All stakeholders are currently focused on the Social Emotional Well being of the students due to the Pandemic and the long term effects of Distance Learning and returning to in person learning. Much of the feedback revolved around services and programs for students struggling with mental health.

Some new feedback that came from the parent group is a desire to increase diversity and inclusivity in the school.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

The focus of all stakeholders on the Social Emotional Well Being of the students played a key role in Goal #2 school culture and climate- specifically with the staffing of the Counselor and Case manager for Sp. Ed and 504 students.

The Advisory Council is focused on increasing inclusivity and diversity at SRACS which contributed to Goal #2 of family engagement.

Feedback from the Parent Association emphasized the importance of ongoing communication as outlined in Goal #2 of family engagement.

Teacher feedback emphasized the importance of collaboration time and professional development as well as continued use of online resources begun during Distance Learning included in Goal #1

Much of Goal #1 and Goal #3 are directly related to the Charter and are the foundational structures necessary to have in place in order to implement the basic directives of the school.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

- 1.1 Purchased new history curriculum for both 5th and 6th grade, replacement math textbooks for both 5th and 6th grade, and library books.
- 1.2 New programs were added in January 2023 and paid for with grant funds: Desmos, Nearpod/Flocabulary.
- 1.3 Real-world experiences included a presentation by Annie Fox, Science Camp, Field trips to the Schultz Museum, the Water Agency, and Jack London State Park. These expenses were paid for by our SFPO or Parent Donations.
- 1.4 We purchased the Renaissance Assessment as we did in previous years. Other assessments were funded by other sources (LGL and CAASPP).
- 1.5 Academic support for struggling students and enrichment opportunities were provided (Homework Help, Lego Robotics, Chess Club). Personnel expenditures were used to pay teachers for their time.
- 1.6 Teachers participated in professional development (Jo Boaler and grade level PD) to create a coherent SRACS program. Teachers also had a half-day PD session with Annie Fox which was paid for by grant funds. Teachers did not attend any conferences this year.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

- 1.1 We were able to use other funds to cover the costs of this strategy. In total, we spent \$24,710.00 of grant funds on curriculum.
- 1.2 We funded Newsela, IXL, and Go Guardian this school year in this strategy.
- 1.3 Our SFPO and parent donations covered all costs associated with real-world experiences.
- 1.4 No substantive differences in our assessments. Students were able to engage in all planned assessments (including CAASPP).
- 1.5 LCAP funds were used to pay for personnel costs to cover after-school Homework Help. Lego Robotics and Chess Club were paid for with grant funds and parent donations.
- 1.6 LCAP funds were used to pay for substitute coverage while teachers participated in professional development.

An explanation of how effective the specific actions were in making progress toward the goal.

- 1.1 Purchasing new curriculum and replacement textbooks gave all students the ability to engage with the SRACS academic program. The new curriculum added to the depth, complexity, and novelty that we strive to have present in all classrooms.
- 1.2 Go Guardian allows us to monitor students while on their chromebooks, and Newsela and IXL helped us progress toward the goal of giving students access to online learning programs to support individualized progress on content standards.
- 1.3 The real-world experiences that students were able to engage in were invaluable.
- 1.4 Students showed growth in all academic areas where there was comparable data from the previous year.
- 1.5 After-school support and enrichment programs supported struggling students and offered additional enrichment for all students.
- 1.6 Professional development was beneficial for teachers and their implementation of the curriculum, especially the Jo Boaler PD for math teachers.

Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning (California *Education Code* [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. Well-developed goals will clearly communicate to educational partners what the LEA plans to accomplish, what the LEA plans to do in order to accomplish the goal, and how the LEA will know when it has accomplished the goal.
